

## WEBSITE TERMS OF USE

Please read the following Website Terms of Use (the “*Terms of Use*”) carefully. These Terms of Use govern your use of the **Capital Markets IQ, LLC** website or any of our affiliate or division websites (including, but are not limited to, “Capital Markets IQ” or “CMIQ” or “Longhorn Capital Advisors” or “LCA” or “Intraline” or “Intraline Asset Management” or “Dynamic Retirement Solutions” or “Accord Capital” or “Surety Wealth Management” or “Veracity Financial Services”) (each a “*Site*”), any mobile applications associated with any Site, or any associated content, material, or functionality contained in any Site (each website and mobile application collectively, the “*Sites*”). The Sites are the property of Capital Markets IQ, LLC (“*CMIQ*,” “*we*,” “*us*” or “*our*”) and its licensors. By accessing, browsing, downloading, using or registering to receive any Content (defined below), you acknowledge that you have read and understand these Terms of Use and that you accept and agree to be fully bound by them. Any use of any Site is at the sole risk of the user. References to “CMIQ” in these Terms of Use shall include all of its members, affiliates, subsidiaries, managers, directors, officers, representatives, agents and employees.

### Updates

We may update these Terms of Use from time to time and may amend them at any time to incorporate additional terms specific to additional features, applications, opportunities, or services that we may make available on or through the Sites. All such updates and modifications are effective immediately upon notice thereof, which we may give by any means, including, but not limited to, by posting a revised version of these Terms of Use on any Site, or providing other notice on the Sites. You should view these Terms of Use often to stay informed of changes that may affect you, as your continued use of the Sites signifies your continuing consent to be bound by these Terms of Use. We expressly reserve the right to make any changes to these Terms of Use, or to any Site and its content, at any time. ### Access and Use
